

**August 15, 2007**

**MINUTES OF A SPECIAL MEETING  
OF THE TOWN COUNCIL  
OF THE TOWN OF FREMONT, INDIANA**

*The Town Council, of the Town of Fremont, Indiana, met in the Town Hall on the 15th day of August, 2007, at 8:07 a.m. in a special meeting pursuant to call in accordance with the rules of the Council.*

*The meeting was called to order by the President of the Council, Loretta S. Smart. On call of the roll, the members of the Council were shown to be present or absent as follows:*

*Chris Snyder, Town Manager, and Mary K. Parsons, Clerk-Treasurer, were also present.*

*The main purpose of the meeting was to issue the final notice to proceed for the by-pass. First item would be to approve the INDOT permit. Chris said the Council would need to make a motion to approve for him to sign the INDOT permit. Steve made the motion for Chris Snyder, as Town Manager, to sign the necessary documents, second by John Ludy, all in favor.*

*John Ludy made the motion to issue the final notice to proceed, second by Steve Brown, all in favor.*

*Chris would like to get approval for E & B Paving to do additional work while they are in town. This would include curb and gutter along Broad Street. Brad Gay, owner of Gay's Party Store, would work with the Town in planting trees in the green space between the street and the curb. Danny Frasier and Jeff Olds, with the Street Department, helped with some of the street work on Ray Clear Lake Road, saving the Town approximately \$15,000.00 in that project with Brooks construction. This will free up funds to do the additional work. Steve Brown made the motion to approve the additional work, second by John Ludy, all in favor. The Council would like to thank the Street Department for their help in the Ray Clear Lake project and Brad Gay for working with the Town on the Wayne street project.*

*Kathy said the 2007 Fremont township fire contract is in need of being amended from \$19,548.10 to \$16,412.00. This is all they are allowed to pay as this is what was approved from the State. Since John is the Clerk for the Trustee and there were only three Council members in attendance, it was decided to wait until next week at the regular meeting. John did not think the Township Board would have a meeting prior to this, so they would not need the executed document.*

*On motion duly made by Council member John Ludy, seconded by Council member Steve Brown and unanimously carried, the meeting was thereupon adjourned at 8:12 a.m.*
