**Public Hearing**- The Public Hearing was for the Town Council to modify, affirm or resend the continuance of the Nuisance Ordinance violation at 206 E Toledo Street owned by Ravens House LLC and Randall Appleton, and to address the non-recurring rates ordinance adoption.

On the account of Ravens House LLC and Randall Appleton at 206 E Toledo St., Fremont, IN 46737, Town Attorney Kurt Bachman reminded the town council that they need to make a decision on the Nuisance Ordinance violation served in September 2022. Town Marshal Joe Patterson presented pictures of the property taken January, 16, 2023 and April 17, 2023 and noted that the items in question move or are replaced with different parts or items that would then be a nuisance. Town Marshal Joe Patterson also stated that the constant changing of the property and the lack of urgency in cleaning up the items that are in violation, he is recommending that this matter should be closed and to move from a nuisance violation to a zoning violation. Councilmember Linda Fulton motioned to rescind the nuisance violation and to start the process for a zoning violation, second by Councilmember Barry Wilcox, all in favor. On the account of the Non-recurring Rates Ordinance 2023-03 and Ordinance 2023-04 the Council did not have any questions or concerns with the Ordinance presented. Once opened for public comment and questions, Town Business owner Darrel Antrup asked if his rates were changing for shutting his water on and off at his seasonal business, and was answered no, just the rates for new taps and after-hours charges were changing, along with disconnection for non-payment and after hour charges were the main changes. There were no further questions from the public.

Councilmember Barry Wilcox motioned to waive the second reading of Ordinance 2023-03 and 2023-04, second by Councilmember Linda Fulton, all in favor

**Utility Credit-** Councilmember Linda Fulton made a motion to approve the utility credits as presented, second by Councilmember Barry Wilcox, all in favor.

Change of Speed Limit Request on SR 827- Council President Steve Brown said he talked to Dana Plattner from INDOT about the 45 mile per hour speed limit being extended south on Sr 827 past the new entrance into Cardinal and Allegheny Coatings, to help keep traffic moving slower for the entrances of the businesses. Councilmember Barry Wilcox motioned to approve the change of speed limit as presented, second by Councilmember Linda Fulton, all in favor.

Approval for Council President to sign INDOT agreements- The Town of Fremont was awarded \$1,000,000.00 in a Community Crossing Grant for 2023. Council President Steve Brown asked for permission for the Council President to sign agreements as needed when they are ready. Councilmember Linda Fulton motioned to approve to allow the Council President to sign the documents, second by Councilmember Ashlee Hoos, all in favor.

**Donation from Back the Blue-** County Council member Christina Cress presented the Fremont Police Department with a donation of \$2,430.00. Town Marshal Joe Patterson said that this donation will go towards the K-9 unit and is greatly appreciated.

**CF 1 Approvals-** Town Court Judge Chris Snyder presented CF 1's for Koester Metals this is the 9<sup>th</sup> year of a 10-year agreement and they are in compliance, and for Miller Waste Mills this is the 2<sup>nd</sup> year of a 4-year agreement and they are also in compliance. Councilmember Linda Fulton motioned to accept the agreement as presented, second by Councilmember Ashlee Hoos, all in favor.
