Council President Linda Fulton turned the Public Hearing over to Town Attorney Tony Manns for the Nuisance Ordinance Violations. Town Attorney Tony Manns said the first to discuss is the continuance for Michael Dewitt. Town Attorney Tony Manns asked Becky Maggart, the Nuisance Ordinance Code Enforcement Officer, if the property is in compliance and she said yes and that it is her recommendation to dismiss the case. Councilmember Barry Wilcox motioned to approve the dismissal, second by Councilmember Ashlee Hoos, all in favor. Town Attorney Tony Manns then turned the Public Hearing over to Town Attorney Kurt Bachman to swear in anyone who would be testifying or representing the 407 N Ray Road property, and Town Nuisance Enforcement Officer, Becky Maggart and Michael S. Stevens were sworn in. Town Attorney Tony Manns then asked for testimony from Town Nuisance Enforcement Officer, Becky Maggart, who said that she had noticed the property in violation of the tall grass and weeds and then noticed the junk vehicles, trash and debris as well. A letter was sent to notify the property owners of the violations with a deadline of compliance. Town Attorney Tony Manns then asked questions regarding the investigation, and stated that the Town is asking fines of \$150 per week for the Nuisances from October 25, 2024. Town Attorney Kurt Bachman then asked Michael Stevens to start his testimony. Property Owner of 407 N Ray Road, Michael Stevens then stated that due to their divorce in progress that it is taking longer to get the nuisances abated. Michael Stevens said he has purchased equipment and has mowed the grass. As for the junk vehicles, he has removed some and the remaining vehicles need to have a lost title applied for, then they can be removed. The remaining trash and debris will be removed immediately. Further questioning by Town Attorney Tony Manns followed and once all involved were done speaking, Town President Linda Fulton closed the Public Hearing, and Council discussion followed. Councilmember Barry Wilcox motioned to approve the continuance to February 18, 2025 with fines incurring until nuisances abated, and if abated Council reserves the right to dismiss all fines at the February Council Meeting, second by Councilmember Ashlee Hoos, all in favor. Councilmember Ashlee Hoos approved the continuance be signed outside of a meeting, second by Councilmember Scott Glendening, all in favor.

Todd Thurber from DLZ also asked for permission to advertise for bids for Pearl Street Project.

Councilmember Scott Glendening motioned to approve as presented, second by Councilmember Barry Wilcox, all in favor.

Todd Thurber from DLZ also said there will be a preconstruction meeting with E & B Paving in February. The next round of Community Crossing Grants will open in January for up to \$1.5 million so he will be getting in contact with Jeff Grimm to discuss which roads need to be included in the projects. DLZ is also working on the right of way documents for the West Alley Project.

Sidewalk bids for Coldwater Street. - Town Attorney Kurt Bachman explained that there were 4 bids that came in for the project and the lowest bidder was missing a document in the packet required by state statute to be considered as a responsive and responsible bidder. Council decided that since this document was missing the next lowest bidder would be considered for the award of the project. Councilmember Barry Wilcox motioned that the lowest bidder was not the most responsive and responsible bid, second by Councilmember Scott Glendening, all in favor. Councilmember Barry Wilcox motioned to approve API as the next lowest, most responsive and most responsible bid, second by Councilmember Scott Glendening, all in favor. Councilmember Ashlee Hoos motioned to sign the agreement outside of a meeting, second by Councilmember Scott Glendening, all in favor. Councilmember Barry Wilcox motioned to prepare award letter and authorize to sign outside of meeting once proper documentation for bond is received, second by Councilmember Ashlee Hoos, all in favor.
