Public Hearing- The Public Hearing was for the Town Council to affirm, modify or rescind the order for the Public Nuisance Ordinance served to Nicole Lensky property owner and Michael DeWitt resident of 406 E. NIPSCO- Town Attorney Kurt Bachman said nothing new to report. Council President Steve Brown said NIPSCO is still checking into a line to the East side of Town and possibly getting gas from a different line to Angola which would open up more gas for Fremont and surrounding areas. Council President Steve Brown said the next call is on March 2, 2023 at 10:00, and will hopefully know more then.

Discussion on eliminating fluoride treatment- Water Superintendent Jeff Olds and Street Superintendent Jeff Grimm explained the need to upgrade the current fluoride system and recommended that the Town of Fremont discontinue adding fluoride to the system. Councilmember Barry Wilcox motioned to eliminate the program as presented, second by Councilmember Ashlee Hoos, all in favor.

Adoption of Title VI Resolution 2023-01- Attorney Kurt Bachman explained the reason needed for the Title VI Resolution. This is to be in compliance with the Federal Government in order to receive grants and programs that would be beneficial to the Town of Fremont, and recommended that the Town of Fremont adopt the Title VI Resolution as presented. Councilmember Barry Wilcox made a motion to adopt the Title VI Resolution 2023-01 as presented, second by Councilmember Linda Fulton, all in favor. Councilmember Barry Wilcox made a motion to waive the second reading for the Title VI Resolution, second by Councilmember Linda Fulton, all in favor.

Mutual Aid Agreement with County- Councilmember Linda Fulton made a motion to approve the Mutual Aid Agreement with Steuben County as presented, second by Ashlee Hoos, all in favor.

Attorney Kurt Bachman would like the agreement signed with Bond Counsel as we include them in some of the preliminary calls for the Fire Station.
