Approval of Minutes- Councilmember Dr. William Stitt made a motion to approve the April minutes, second by Councilmember Ashlee Hoos, all in favor.

Approval of Claims, Payroll, Comp Time, Fund Report and Appropriation Report- Councilmember Ashlee Hoos moved to approve claims, payroll, comp time, Fund and Appropriation reports as presented, second by Councilmember Dr. William, all in favor.

OLD BUSINESS:

DLZ Updates- Todd Thurber from DLZ said current street projects, for 2024 and 2025 E & B paving is about 60% completed and have requested pay app 1 for 2024 Street for \$642,948.89 and pay app 1 for 2025 Pearl Street for \$108, 6047.81. Councilmember Dr. William Stitt motioned to approve both pay apps as presented, second by Councilmember Ashlee Hoos, all in favor. Todd Thurber from DLZ also said that he had the next grant ready to advertise this week to be ready for bids starting June 3, 2025. Todd Thurber from DLZ said that the Coldwater Sidewalk is complete and API has requested pay app 1 for 225,039.32. Councilmember Ashlee Hoos motioned to approve as presented, second by Councilmember Dr. William Stitt, all in favor. Todd Thurber from DLZ said the Hope Drive Sidewalk is complete and T & S Concrete requested the retainage of \$500, Councilmember Dr. William Stitt motioned to hold the payment until the grass is growing as none is yet and may need to be redone, second Councilmember Ashlee Hoos, all in favor.

Ordinance 2025-06 Downtown apartments- Councilmember Dr. William Stitt motioned to approve as presented, second by Councilmember Ashlee Hoos, all in favor.

NEW BUSINESS:

Utility Credits- Councilmember Ashlee Hoos made a motion to approve the utility credits as presented, second by Councilmember Dr. William Stitt, all in favor.

CF-1's- Isaac Lee from Steuben County Economic Development Corp presented the CF-1's for Cardinal IG and his recommendation is they are all in compliance. Councilmember Ashlee Hoos motioned to approve all the CF-1's for Cardinal IG as presented, second by Councilmember Dr. William Stitt, all in favor.

County Agreement Will Howard- County Commissioner Will Howard spoke on the agreement between Steuben County and the communities within the County, involved with the NIPSCO natural gas shortage. The agreement is for each community to pay an amount determined by population with Steuben County paying the majority to try to get NIPSCO to supply more natural gas to the area. Discussion followed. Councilmember Dr. William Stitt motioned to approve as presented, second by Councilmember Ashlee Hoos, all in favor.

Permitting process- Town Attorney Tony Manns discussed an Ordinance to streamline the permitting process for the Right of Way areas in the Town of Fremont to alleviate multiple agreements needed for projects. Councilmember Ashlee Hoos motioned to proceed with the Attorney to prepare the Ordinance, second by Councilmember Dr. William Stitt, all in favor.

Appraisals 103 N Pleasant St.- Council President Linda Fulton said the two appraisals that were received for the property were done and an offer for the property was given and rejected as of now. Council President Linda Fulton asked for permission to sign an agreement outside of a meeting if the seller decides to accept the offer, or for permission to attend the auction to bid on property if needed. Councilmember Dr. William Stitt motioned to approve as presented, second by Councilmember Ashlee Hoos, all in favor.

Spring Cleanup- Council President Linda Fulton said the town wide Spring Clean-up is scheduled for Thursday, May 15, 2025.

Veteran banners- Council President Linda Fulton said the Town of Fremont has implemented a Hometown Hero Banner program and were hoping to receive seven applications. The Town received sixty applications and will be hanging the banners by the end of the week.

Town Attorney, Tony Manns, suggested to hire as an independent contractor with direct supervision by the Council to avoid any violation of the nepotism laws.
